Student Parking: *(Driving and Parking Regulations on the back of this application)*

- Parking applications must be completed fully and accurately.
- Students will present their **valid driver license**, a **vehicle registration** and **insurance card** to complete the registration.
- **Parking is a privilege, not a right. Parking permits are issued to junior or senior level students.**
- Parking permits **MUST** be displayed on the rear-view mirror.
- Parking spaces are limited and restricted based on availability. Permits are issued on a first come, first serve basis.
- Cost of parking permit (*New and Renewal*) is **\$10.00**. Parking is a privilege; all costs are non-refundable. (*Cash or check payable to JSASD*)
- **Parking Permits are the property of Jersey Shore Area School District and MUST be returned to the main office at the end of the school year or at the time of withdrawal.**
- Student parking is **in tier 2, tier 3**, and along the **track fence ONLY**.
- Students entering from the rear of the high school will turn **right** at the "T" in the road and proceed to tier 2 or tier 3.

Driving and Parking Regulations

The following regulations will be adhered to by all student drivers. Upon signing the contract, I agree to the following:

1. **Parking is a privilege, not a right. Parking Permits are for Junior/Senior level students ONLY.**
2. Students are required to have a **valid parking permit** to park at Jersey Shore Area Senior High School.
3. The “parking permit/decals” will be displayed on the back of the review mirror at all times for the front lot. Displayed on the rear of the vehicle at the track lot.
4. Students must back into the parking spaces at the front lot.
5. All traffic signs and speed limits (**15 mph**) on school property will be obeyed.
6. Access to a vehicle during the school day is limited and only allowed by permission through the main office.
7. Loitering in the school parking lot is prohibited.
8. Student vehicles are not to be used as a locker. Student access to their vehicles is limited to emergency or extenuating circumstances only. Parking permits may be revoked if students abuse this privilege.
9. Student parking is available in **tier 2, tier 3** and along the **track fence**.
10. Drivers will be completely stopped before picking up any passengers.
11. Students are responsible to report updated vehicle information to the main office.
12. Students who allow an underclassman or unauthorized student to use their parking decal for any reason will lose their parking privileges for a period of time.
13. Students will conduct themselves in a manner consistent with good citizenship.
14. **Parking Permits are the property of Jersey Shore Area School District and MUST be return to the school office. Lost and/or damaged permits will be replaced at a cost to the permit holder.**
15. Violations of these regulations and/or reckless /careless driving of any kind is not permitted and may result in disciplinary action, traffic citation and/or loss of privilege.
 - First Offense, Permit suspended for twenty (20) days.
 - Second Offense, Permit suspended for forty-five (45) days.
 - Third Offense, Permit suspended for the remainder of the school year.
16. Any act that is a chargeable violation of the PA Vehicle Code (Title 75) will result in immediate revocation of the parking permit by school administration.
17. Violations of parking regulations may result in a citation issued by the TVRPD.
18. **Vehicles parked on school property can be searched at any time.**
19. I have read the guidelines on this application and I understand and accept the responsibilities of a Student Driver at Jersey Shore Area Senior High School.
20. Students’ who are illegally parked, not parked in the student lots, and/or do not properly display an approved parking permit, will be ticketed and/or towed at the owner’s expense.
