1. Describe the host's educational oversight to ensure students with disabilities are educated in the least restrictive environment while in the 1306 facility? (If not a host, answer as if you were.)

If students are placed in a 1306 Residential Facility outside of the Jersey Shore Area School District, personnel from the facility will send an enrollment form to JSASD as soon as possible providing all pertinent information (i.e., name, DOB, etc.) and indicate whether the student has an IEP or 504 accommodation plan. A designated LEA of Jersey Shore Area School District will attend meetings for the student, either in person, virtually, or by phone, while the student is placed in the facility. All students residing in any 1306 residential facility (with or without an IEP or 504 plan) will receive an education that complies with Chapter 4 and is provided by teachers appropriately certificated by the Pennsylvania Department of Education. Instructional opportunities at any 1306 facility will include teacher-led instruction and computer-based instruction with teacher and/or counselor guidance. Either opportunity can be supplemented or supported by special education services. Each student will have access to either instructional opportunity for each content area, depending upon individual student need. Problems or barriers that exist include student mobility, student records attainment, and court orders. Some students are in 1306 facilities for a very short period of time. Students may be in and out of a facility before the district is aware that they were even placed there. Student records, including special education records, are not always forwarded from the last LEA in a timely fashion despite multiple requests for said records. Finally, upon occasion, a court order has been received stipulating that a student attend an educational program outside JSASD despite temporary residence within JSASD.

2. Describe the district's procedures for communicating with 1306 facilities and how the district ensures a successful transition back to school?

When a student is ready to transition back to Jersey Shore Area School District (JSASD), a representative from the district will be notified by the facility of the transition. The representative will be involved in helping to plan the transition schedule and arranging for services that the student will need to help him/her be successful with the transition. Communication can occur via in-person meeting, virtual meetings, or phone calls.

The district does not have any facilities for incarcerated students within its boundaries. When the district is notified by the prison, the commonwealth, or by the educational entity providing the educational services at a facility that a JSASD student is incarcerated, JSASD works with staff from those facilities and the school district/intermediate units that have educational responsibilities to ensure that the student's needs are addressed. JSASD assists with the exchange of educational records, child find, evaluation, and Individualized Education Program development.

Least Restrictive Environment

1. Review the district's most recent data for Least Restrictive Environment. Highlight areas of improvement.

Using the 2022-2023 Special Education Data Report, 76.4% of Jersey Shore Area School District special education students were educated in the regular class for 80% or more of the day. 12% of special education students were in the regular class less than 40% of the day. The data shows 0% of special education students were receiving their educational programming in other settings. The district always looks at the regular education classroom as the first placement for students. We look at the individual needs of students and determine the amount and type of support that is necessary for the student to be able to make academic progress. We will continue to look at how we can decrease the percentage of students who are in the regular education class for less than 40% of the day, taking into consideration all of the supports that can be provided in the regular education classroom to help students be more successful in that environment.

2. What universal practices does the district utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?

At the elementary level (K-5), students are screened using Acadience (DIBELS) in reading and math. Students also participate in STAR reading assessments and iReady assessments to gain baseline information. This information helps teachers develop interventions/programs to work with students to make academic progress. For social/emotional needs, teachers K-5 complete the SRSS (Student Risk Screening Scale) to determine any external or internal needs. The character committee also provides social/emotional lessons that are shared with the LIT teachers and completed during that special time with students at the elementary level. There is also an elementary level SAP team that meets to discuss students needing extra services and support. At the middle level (6-8), students take iReady assessments as well. They also piloted Firefly in the fall and plan to take it again in spring. For social/emotional needs, teachers 6-8 complete the SRSS (Student Risk Screening Scale) to determine any external or internal needs. They also implement Wellness Wednesdays every other week where teachers teach a lesson that was developed by the counselor. There is also a MS SAP team that meets to discuss students needing extra services and supports. At the high school level (9-12), they piloted Firefly in Algebra and English with the plan to implement that fully when the state is ready. iReady benchmark assessments are also utilized to gain baseline information. As for social/emotional needs, the high school implemented Mondays Matter-a PLC works with the counselors on establishing lessons. They also have a Renaissance club that creates lessons for that as well. There is also a HS SAP team that meets to discuss students needing extra services and supports. Students in grades K-5 are instructed using Second Step curriculum to develop their social/emotional skills.

3. Describe the academic programming and training efforts the LEA utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.

The LEA utilizes partnerships with PaTTAN and the IU to offer training for teachers to help support students in the general education

curriculum. Trainings have been offered on co-teaching and differentiation of instruction to help support students in the general education curriculum. Teachers are also encouraged to seek out any trainings that they feel would benefit their classrooms.

4. Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities.

Supplementary aids and services utilized for students to access extracurricular activities include assistive technology, adult support, and transportation services. Students who wish to participate in extracurricular activities will be given appropriate support to be able to participate. If students require assistive technology to communicate with event/activity staff, it will be provided. We have students who have language apps (i.e., ProLoQuo2Go) on their devices. Students would be able to utilize their device while at the extracurricular activity. If students require adult support, arrangements would be made to have an adult support them at the activity so they could participate to their maximum potential. The district would provide transportation for students to have access to extracurricular activities, if needed. Each case would be looked at individually and supports would be provided based on the student's needs.

5. Describe the District procedures, which ensure that, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district lead extracurricular activities?

Students who are placed in private institutions are monitored by the LEA. Students are educated with regular education peers as deemed appropriate by their school team. Students have access to extracurricular activities and the district works with families to help them gain access to these activities. For example, if a student would need transportation to access extracurricular activities, the district would help arrange it so the student could meaningfully participate in the chosen activity.

6. Discuss the district's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out of district placement chart)

The district currently offers learning support, life skills support, Itinerant autistic support and emotional support at all levels. We continue to monitor the needs of all students and determine what other supports may be needed. For students with significant behavioral challenges, the district needs to continue to assess programming options that are available for these students.

1. How does the district support the emotional, social needs of students with disabilities?

The district supports the emotional, social needs of students with disabilities by providing emotional support services district wide. Emotional support services are available for students in grades K-12. The district looks to support students in the regular education classroom first and only moves to a more restrictive placement when behaviors impede the student's learning or the learning of others. In addition to emotional support services, itinerant autistic support services are also available to support the social needs of students with an autism spectrum disorder. Social stories are utilized to help students understand how to respond in certain social situations. The district also uses Second Step social, emotional programs in grades K-5 for all students. Our guidance counselor at the elementary level also runs different social groups for students who are struggling with different social and emotional situations. As a district, we have 59 staff members who are trained in QBS de-escalation strategies. QBS de-escalation strategies offers teachers tools to use with their students when emotional needs escalate.

2. Describe training provided to staff in the use of positive behavior supports, de-escalation techniques and responses to behavior that may require immediate intervention.

The district has teams of staff in each building who are trained in de-escalation at every level. The district has two in-house trainers who provide training in QBS. QBS emphasizes de-escalation strategies to help calm students down when they are escalated. Safe physical holds will be used as a last measure when the student represents a danger to him/herself or others.

3. Describe the district positive school wide support programs.

The district utilizes school wide support programs at each level. Each level has 3-5 broad school rules for students to follow. At the elementary level, the acronym BARK is used - B: Be Respectful; A: Act Responsibly; R: Remember Safety; K: Keep on Learning. At the middle school level, they utilize the Habits of a Bulldog nation. These habits include School/Class Participation (I am a thoughtful, inquisitive member of the classroom community). Appropriate Conduct (My behavior allows me, and others, to learn independently and/or collaboratively. My behavior is appropriate both in person and online). Preparedness (I am always prepared to learn and have my

materials ready). Accountability (My time and energy are spent on learning. I have set positive goals and am accountable for working hard to reach them). Community Conduct (I am always looking for ways to help those around me be the best they can be). At the high school level, the acronym SHORE is used - S: Safety; H: Honesty; O: Ownership; R: Respect; E: Enthusiasm. Students are taught appropriate behavior in all school settings. A teacher committee evaluates the data and helps determine incentives/rewards. Student Committee and Renaissance Club work alongside the teachers to help with incentives and student/teacher recognition. Students submit SHORE Pride tickets for weekly drawings and there are special drawings held throughout the year as well. SHORE expectations are posted in classrooms and around the building. Each level has a school-wide positive reinforcement plan for all students and staff. The reinforcement plan will encourage and reward positive behaviors on a frequent basis. Along with reinforcement, each level also has a procedure for handling chronic behavior difficulties.

4. Describe the district school-based behavior health services.

The district employs guidance counselors (5) and school psychologists (2) who can assist students with school-based behavioral health issues. In addition, the district partners with CSG to provide counseling to students in the school setting. The district has a part-time social worker to assist with behavioral health needs as well. The district also has a School Outreach Worker who works with families to address academic or behavioral concerns. The School Outreach Worker is able to help families make connections with agencies to obtain services that may be needed. The district contracts with CSG and Crossroads Counseling to provide telepsychiatry and in-school counseling.

5. Describe the district restraint procedure.

When behaviors occur, district staff will first attempt to de-escalate the student using de-escalation strategies from QBS. If the student does not respond to de-escalation attempts and behaviors escalate to a point where the student is a danger to him/herself or others, restraints will be used. When a student's behavior begins to escalate, the teacher/staff would utilize strategies (Help, Prompt, Wait) to help the student return to a calm state. These strategies could involve providing options, removing the rest of the class, etc. Staff would continue to monitor the student and only if the student becomes a danger to him/herself or others, would a safe physical hold be utilized. Staff are trained to understand that annoying behaviors (screaming, spitting, etc.) are not reasons to utilize a safe physical hold with a child. QBS emphasizes the use of de-escalation strategies first and physical management only as a last resort when the student is an immediate danger to himself or others.

The district does not currently have any students who are placed on Instruction Conducted in the Home who are at a substantial risk of waiting more than 30 days for an appropriate educational placement. When we have students that placement may be difficult for, we have been utilizing the CASSP format through Lycoming County. By bringing multiple agencies to the table, we are able to discuss the student's needs and discuss options for the student.
