I attest that the following courses shall be taught at the secondary level: English, to include language, literature, speech and composition; science; geography; social studies, to include civics, world history, history of the United States and Pennsylvania; mathematics, to include general mathematics, algebra and geometry; art; music; physical education; health; and safety education, including regular and continuous instruction in the dangers and prevention of fires. Such courses of study may include, at the discretion of the supervisor of the home education program, economics; biology; chemistry; foreign languages; trigonometry; or other age-appropriate courses as contained in

Chapter 5 (Curriculum Requirements) of the State Board of Education.

I attest that the student has received the immunizations required by law, or that the student has a medical, religious, or philosophical exemption.

I attest that the student has received the health and medical services required by law for the students of the child's age or grade level.

I attest that no adult living in the home, or any person having legal custody of the student, has been convicted within five years of today's date of any of the criminal offenses enumerated in Section 111 of the Pennsylvania Consolidated Statutes.

I attest that the home education program shall comply with the provisions of Section 13-1327.1 of the Pennsylvania Statutes Annotated and that the notarized affidavit shall be satisfactory evidence thereof.

The PA Home Education law requires that "in grades three, five, and eight results of nationally normed standardized achievement tests in reading/language arts and mathematics or the results of Statewide tests administered in these grade levels" be included in the child's portfolio.
