 - The eligible recipient shall NOT have attained the Honor Roll (or its equivalent) during the recipient’s high school career
 - High School career shall be defined as grade nine (9) through twelve (12).
- The potential recipient shall have been accepted and be enrolled in the freshman class of any of the following institutions with the field of study in accounting/business:
 - Pennsylvania College of Technology (Penn College)
 - Pennsylvania State University (PSU)
 - Commonwealth University of Pennsylvania – Lock Haven (LHU)
